RESEARCH PROJECTS

Everyday ethics in community mental health services, Milwaukee, WI (2004 to 2011)

Ethnographic study of the social origins and everyday expression of moral concerns by providers of community-based services for people with severe and persistent mental illness. Methods include participant observation of "assertive community treatment" programs: attending staff meetings, and accompanying case managers' to clients' homes, commitment hearings, meetings with psychiatrists, lawyers and family members, etc. This study explores how bioethics rhetoric is co-produced with institutional arrangements as well as ordinary clinical practice. It clarifies the gap between formal bioethics and intuitive moral explanations. It develops a practice-based theory of how clinicians use moral discourse to articulate the limits of professional expertise, the ambiguities of their work, and their negotiations with clients and other social actors.

Ethnicity, citizenship, family: identity after the Human Genome Project (2000-2002)

Co-principal investigator with an interdisciplinary team to explore ethical aspects of new genetic knowledge about ethnic, tribal, and national identity. Case studies include use of genetic tracing by American Indians for tribal status, by diasporic Jews for the right of return to Israel, and by African-Americans to trace connections with contemporary West African populations. Methods include interviewing American and British geneticists and facilitating inter-disciplinary seminars among genetics, bioethicists, philosophers, and individuals seeking genetic validation of identity claims. Funded by the National Institute of Health (National Human Genome Research Institute)

Marginality and religious conversion among transnational Haitians, French West Indies (1994 and 1996)

Field research on the production of community among Haitian migrants in Pointe-à-Pitre, Guadeloupe (French West Indies), including religious conversion and changing discourses of sickness and health.

Methods included participating in Pentecostal rituals of worship and healing; documenting life-histories of converts and pastors; interviewing Haitian migrants, Guadeloupeans, and foreign missionaries about marginalization, the growth of fundamentalist churches, and migrants' use of religious healing and biomedical services; and archival research on migration and the French politics of assimilation.

Healing, religion, and medical pluralism, Les Cayes, Haiti (1987-88 and 1992)

Ethnographic fieldwork on rural Haitian culture and social organization, with a focus on religious pluralism and healing practices. Methods included collecting life-histories of healing specialists; participating in prayer meetings and spirit divination ceremonies; recording curing rituals and informal interactions between healers, clients, and their kin; documenting prospective cases of illness and care-seeking; analyzing clinical services at the local dispensary; and extensive interviewing of villagers about their therapeutic knowledge, religious affiliation, and moral commentaries on affliction.

Anthropology of chronic pain, Cambridge, Mass. (1983-87)

Multi-disciplinary, collaborative research on the experience of pain and its representation in biomedical practice and personal narratives. Methods included extensive open-ended and psychiatric diagnostic interviews with 15 white, middle-class Americans with chronic pain; participation in their support groups and therapy sessions; mediation between university research group and clinicians; devising and administering demographic and life-history questionnaires, and writing case studies for book on the anthropology of chronic pain.

Transcultural psychiatry, Dakar, Senegal (1985)
