

TUTORIAL on PAWS FINANCE INFORMATION

Your PAWS Student Services Center is where you will find information about your university charges and financial aid. You will be sent an email if additional information is needed as well as once your financial aid is determined. You will also be sent an email once charges are assessed. Make sure to check PAWS and your email (UWM email if one has been assigned to you) on a regular basis. In order to view your aid offer and online billing statement, you will need to log in to your PAWS Account at <https://paws.uwm.edu>. Use this document to help you understand information related to finances. Pictures in this document are only examples. Please contact the [Student Financial Service Center](#) (the place for all questions related to billing, financial aid, and scholarships) with any questions.

To Do List

If you have any Items in the Holds section, you may not be able to enroll in future semesters, so make sure to review them before your enrollment appointment. Missing information will usually show up in your To Do List which is located in the right sidebar. Click on the **More** link or each individual item for details and instructions on what is needed. If you have any To Do items needed to finalize your financial aid application, that means your file is not currently being reviewed.

VIEW BILLING STATEMENT

Students are not mailed paper bills. They are sent an email directing them to their Online Billing Statement. Unfortunately, these are often not available until the end of July prior to the start of the fall semester.

1. Click on “View Billing Statement” under the Finances section.
2. Click on “Get Billing Statement.” This will bring up your billing statement.

MAKING A PAYMENT

The easiest way to make a payment is online using the link in your PAWS Student Center called **Payment Center**.

Scenario #1: If you do not see Aid Year 2025, we have not received the results of a FAFSA for 2024-25.

Scenario #2: If you have access to Aid Year 2025, but receive the message "You have no financial aid awards available for viewing in this aid year," we have your results, but your aid eligibility has not been determined. Check your PAWS To Do List and/or your UWM email for communications from us to make sure we have not requested additional information from you.

Scenario #3: If you do see aid, but do not have access to "Accept/Decline," this means we are finalizing your file. You will receive an email when you are able to officially accept or decline your aid.

There are numerous delays for 2024-25. The earliest schools will receive any FAFSA results will most likely be mid-March. Students should not expect to see aid offers until late April at the earliest.

It takes about 4-6 weeks for your file to be reviewed and finalized once all the necessary documents are received. You will be sent an email once your aid is ready for you to review and Accept/Decline.

Once you receive the email, you will have access to your Award Summary after clicking on the 2025 Year. Make sure to scroll down to see the aid broken down by term.

IMPORTANT—we do not have 2024-25 pictures. As such, these represent 2023-24, and do not reflect changes in some of the terminology (i.e., expected family contribution has been replaced with student aid index). Also, the way the items in the budget display may be different. However, the concepts haven’t changed.

Message

Federal Direct Unsubsidized Loan is a loan that must be repaid and requires half-time enrollment to receive any funds. Although payments are deferred as long as you are enrolled at least half-time, interest begins to accrue as soon as funds disburse. For funds to disburse, you must have completed a Federal Direct Master Promissory Note (MPN). If you have never borrowed a student loan before you will also need to complete Entrance Loan Counseling. Please visit studentaid.gov to review detailed loan term information and to complete all requirements.

1. After reviewing your aid messages, accept/reduce or decline any funds offered to you. To accept or decline funds, click on the check box next to each item.
2. Click on the "submit" button to finalize your accepted aid.

If you do not want to accept the full amount, you can reduce the amount offered.

1. Accept the offer.
2. Change the amount you want to receive in the white fillable box that opens up. If the aid offered is for two semesters, you will then receive half for fall and half for spring.
3. Click on the "submit" button to finalize your accepted aid.

You have 30 days from the date the aid is posted or until June 1 before the academic year, whichever is later, to accept your aid. If you have not accepted your aid by then, we will cancel it. If you decline or we cancel your aid, you are able to request to have it re-offered as long as you are still eligible.

You should notify the Student Financial Service Center if you are graduating in December or will not be enrolling in a term in which you were offered financial aid.

 Satisfactory academic progress (SAP) is used to define successful completion of coursework to maintain eligibility for student financial aid. Federal regulations require this institution to establish, publish and apply standards to monitor your progress toward completion of your certificate or degree program. If you fail to meet these standards, you will be placed on financial aid warning or suspension. Completion toward your program is measured by GPA, time frame to completion, and percentage of courses completed you attempt.

If you are not meeting SAP requirements, you are not eligible for financial aid. You could meet with a financial aid advisor if you think you may qualify for an appeal.

The View Scheduled Disbursement Dates is a hyperlink, but you won't see any amounts until the aid actually disburses. Disbursement begins 10 days prior to the start of a semester. If you click on it before disbursement, it will look like this:
