## Current State of DACA as of April 2020

- Your DACA is valid until its expiration date. All renewals continue to be reviewed, however, new applications are not being processed.  
Look at your I-795 Approval Notice and the bottom of your EAD to determine the expiration date.
- DACA recipients are encouraged to renew within the 150 day window-frame prior to its expiration date
- A Supreme Court decision on DACA is expected by June 2020
