 - i. Mike believes most of the edits look reasonable, but the proposed directional signs might be difficult due to financial limitations. It may take 1-3 years to complete that aspect.
 - b. Return to campus supporting LGBTQ+ students/campus communities (All)

- i. Kelly – From the scenario planning group: one of the aspects of returning to campus will be to recognize our collective experiences and traumas over the past year+. The group will be developing a toolkit to support areas in planning.
 - c. Athlete Ally (Jen)
 - i. UWM scored a 90 in the Athlete Ally index. A communications push that includes interviews with folks from athletics will be out soon.

 - i. In addition to problems with how they ask about sex/gender, there are also issues with how the testing screening questions ask about race/ethnicity.
- b. Staywell Interface Initiative (Cary/Tim/Jen)
 - i. Shifting this standing item to “healthcare interfaces” to the future.
 - ii. Some good aspects about the Advocate Aurora interface, but also some not good aspects. The not good aspects were brought to Advocate Aurora in late March, follow up is needed.
 - iii. Addressing the testing interface is in the earliest stages.
- c. Response to Homophobic/Transphobic Speakers (Gladys)

- d. IRB Guidelines (Cary/Whitney/Dante/Sarah)
 - i. Nothing substantial this month – in early correspondence
- e. Trans WI legislation (Kelly/Jen/Luke)
 - i. The talking points from last meeting were sent to the Chancellor and eventually the UW System/Regents.
 - ii. Chancellor Mone is involved with the Horizon League and they are working on a response.
 - iii. VC Luljak recommended that entities like the LGBTQ+RC wait on the UW System advocacy before signing onto letters.
 - iv. Sarah: NCAA put out a press release this week stating that championship events won’t take place in states that pass this type of legislation.
 - v. Cary: a reality check that there are hardly any trans athletes participating due to discrimination and lack of safety should be a talking point.
