To Whom It May Concern:

It is indeed a pleasure to submit my cover letter, vita, and five references for the position of Director, Lubar Entrepreneurship Center at the University of Wisconsin-Milwaukee. This is a very exciting position and a great opportunity to lead an important center at UWM and in our city. I am interested in the position because I believe my strong desire to achieve, problem solving abilities, training, and expertise will help the LEC continue to provide the requisite tools and opportunities to UWM students, faculty, and staff to transform their ideas in entrepreneurial realities leading to wealth creation and jobs creation.

When reviewing the preferred qualifications, I can identify ways in which I meet those expectations. Many of my strengths match and exceed the duties and responsibilities of the position. I have over 40+ years of professional experience of which 19 of those years were spent as a college professor and administrator, including 3 and a half of those years here in Milwaukee at UWM and Marquette University in high profile academic and leadership positions.

I am particularly thankful for my experiences in higher education because I had numerous opportunities to do first rate entrepreneurship work. At Auburn University (1993-2005) I created a national conference aimed at disseminating information pertaining to the critical issues affecting African Americans in business. My efforts resulted in the conference being held in Cape Town South Africa with the support of the U.S. Department of Commerce Minority Business Development Agency and four higher education institutions in South Africa's Western Cape.

The spillover effect of the conference led to the establishment of the *Entrepreneurship Policy Journal* and an edited book, *Entrepreneurship in South Africa and the United States: Comparative Studies*, highlighting several of the papers presented at the conference over its many years. The conference also led to Auburn establishing an academic exchange program with Stellenbosch University that provided Auburn faculty, students, and administrators with an opportunity to gain international experience in post-apartheid South Africa. Another entrepreneurship activity at Auburn included working with officials at the University of Alabama to implement and oversee an Appalachian Regional Commission (ARC) funded project to establish youth entrepreneurship curricula in four rural Alabama high schools in the ARC region.

When you embark upon a journey to do first rate entrepreneurship work you get noticed. This was the case when my work was noticed 1000 miles away by Dr. Chales Kroncke, University of Wisconsin-Milwaukee's former Dean School of Business who recruited me from Auburn University in 2002 for a one year visiting appointment specifically to research and coordinate initiatives to increase entrepreneurship participation for Milwaukee's inner-city residents.

In 2005 I was hired by Marquette University as their first chief diversity officer. In this capacity, I built relationships with business leaders across the city, and I even arranged for a \$1 million dollar deposit relationship between the institution and former Legacy Bank which at that time was the nation's 13th largest African American owned bank. As a member of the bank's board of directors I led the effort that created the bank's foundation and served as its first President. The foundation to-date is Wisconsin's largest African American owned and controlled foundation and continues to support entrepreneurial

and innovation activities in Milwaukee. Another important entrepreneurship activity was my leadership in bringing to Milwaukee national entrepreneurship speakers to share their wisdom and interface with Milwaukee's business leaders. This was all done as a member of Legacy Bank's board of directors.

As Colgate University's Vice President and Dean of Diversity (2008-2011), I led a campus wide effort to examine entrepreneurship as a new academic revenue source. I also worked with Colgate alumni to market a new start-up venture fund specifically targeting Colgate students, faculty, and other members of the Colgate family.

The pinnacle of my professional experience was my decision in 2013 to start my own consulting business that specializes in using entrepreneurship approaches and economic development strategies to provide real-time knowledge, measured success, and collective prosperity to my clients. Simply stated, I own and operate an entrepreneurship centric consulting firm (Global Capital Group, LLC-GCG).

GCG's client base is very diverse in terms of sectors like universities, corporate entities, local governments, state governments, social service agencies, small and medium size businesses, business improvement districts, and supplier diversity organizations. For instance, I currently serve as the Administrator for the Business Connection Module of The Business Council (TBC). TBC is a Milwaukee non-profit that assist minority-owned businesses foster collaborations and access corporate chains. As Administrator, I am responsible for developing, overseeing, and delivering the Module's curriculum for participating minority business enterprises and participating corporations.

My consulting firm's bread and butter is strategic planning. I've developed strategy documents for two of Milwaukee's largest corporations. My company conducted market research that assisted American Family Mutual Insurance Company evaluate and develop goals to establish innovative and impactful partnerships with Milwaukee's K-12 schools as part of the company's overall strategy to develop remote corporate workplace in downtown Milwaukee. Also, I developed a community engagement plan for Ascension Wisconsin which helped the company initiate open partner networking for the betterment of health factors and outcomes in Ascension service areas.

In terms of a large area non-profit, I've developed the Social Development Commission's past two strategic plans (2023-2026 and 2019-2024) using a planning model that has helped SDC trek through a complex and changing world with the hope of being able to actualize a different future.

In 2022, I developed a 20-year Comprehensive Strategic Plan for the Board of Supervisors for Bolivar County, Mississippi. The plan provided the county with a long-term road map for growth, investments, and organizational development. The plan provided the county with an opportunity to look beyond municipal borders and create a shared vision in addition to providing the county with an official public document to make decisions about the county's future physical development.

Equally important to my for-profit consultancy is my non-profit institute (Manufacturing Diversity Institute-MDI) that is in business to ensure that individuals from underserved communities are successful in manufacturing careers and businesses. With a recent grant of \$300,000 from the Wisconsin Governor's Office, I lead a team that is working to establish a Building Construction Advanced Manufacturing Institute of Excellence (BCAMIE). The aim of the project is to support the emerging industrialized construction cluster by using the proposed institute to help address Southeast Wisconsin's issues like affordable housing, green energy infrastructure, high quality green manufacturing jobs, supply chain opportunities for minority business enterprises (MBEs) and addressing disparities among minority populations. Major activities include but not limited to developing a solid business case, site selection, site environmental assessment, and developing training modules for minority entrepreneurs who are interested in supply chain opportunities in industrialized construction.

Both of my current business ventures have had significant impact on Milwaukee's entrepreneurial ecosystem. But most importantly, these opportunities showcase me as someone who not only talks entrepreneurship but as someone who practices entrepreneurship. I believe that upon your review, you will recognize that my experiences, credentials, and proven track record of entrepreneurship success are exactly what LEC needs to drive entrepreneurship, innovation, and support the development of new enterprises for the UWM community. I am confident that my experiences and unique skills will provide the LEC with an invaluable resource. I look forward to discussing this opportunity with you and others.
