**DPI ACT 31 Requirement:** By Law, all students seeking licensure through the state of Wisconsin are required to take a course regarding Native American history, literature or culture. These courses (to be taken at UWM) include: Ethnic Studies 203, History 263, Anthropology 213 or the ACT 31 workshop.
