The University of Wisconsin- Milwaukee embraces the principles of free speech and the resulting free exchange of ideas. Accordingly, it is the university's intention to allow the unimpeded presentation of ideas by members of the university community in university authorized forums without interference from those who do not agree with the ideas presented while still allowing opposing views to be heard in appropriate alternate forums and/or locations. The University of Wisconsin-Milwaukee Police Department will respond to demonstrations, protests or other events on University controlled property requiring crowd management to safeguard the rights of any person or group to conduct a peaceful and lawful demonstration and and to maintain order and protect <u>safety</u>. Jife and property.

Section UWS 18.11(4), Wisconsin Administrative Code, establishes restrictions on <u>certain</u> activities in order to preserve the order, which is necessary for the enjoyment of freedom by members of the university community and to prevent disruption of <u>and access to</u> instruction, research, public service, <u>extracurricular</u>, or administrative functions. For purposes of this section, the Chancellor's designee shall be the Vice Chancellor for Finance and Administrative Affairs and/or the Vice Chancellor's designee.

The University of Wisconsin--Milwaukee will enforce these Administrative Code provisions, as well as other laws, to assure that protests do not occur on university lands or in university buildings which would interfere with or disrupt the function of authorized activities.

An individual or group of individuals who may be in violation of the <u>C</u>eode -may face penalties as determined under sec. <u>Chapter UWS 1817-13</u> and/or <u>sec. Chapter UWS 1718-10</u>. When using the authority granted by the <u>Administrative C</u>eode, the designated university official(s) will direct the individual or group protesting to: 1) <u>r</u>Refrain from protesting except in designated areas outside of the university building, <u>and/or 2) <u>c</u>Comply with specific guidelines set for the building, area, or event.</u>

If the individual or group fails to move the protest/demonstration to the designated area or comply with the limitations on activity in the building or on university lands set by the university official(s), the university official(s) <u>mayean</u> then declare the assembly to be unlawful and inform the individuals or group that they are subject to removal, immediate arrest, and/or the penalties of see. Chapters UWS <u>17</u> and/or <u>18-13</u> and/or sec. <u>UWS <u>17.10</u> and/or any other applicable laws.</u>

The University Police officials and/or UWM or other law enforcement officers may take appropriate actions to remove and/or arrest those individuals found to be in violation of the this Policy, the Administrative Code, and/or other applicable laws.
