D. Accelerated Master's Degree Policy

Past practice at UWM allowed up to 30 graduate credits to count back toward the undergraduate degree. Best practices and DOE guidelines suggest that 15 should be the maximum. APCC and GFC met to rework the UWM policy to meet these guidelines and help keep students Pell-eligible as long as possible. The new policy allows 21 double-counted credits, with 15 of these credits counting back toward the undergraduate degree. The Registrar's Office is creating a new system that will facilitate this (see below). Advanced students will still finish in five years.

6. Old Business:

A. JAPAN 345: Japanese News Media

Kim Pietsch moved to approve this course. Laura Stark seconded and the motion passed unanimously.

7. New Business:

A. Undergraduate Program Review – <u>International Studies</u>

The program has grown despite limited resources and did an excellent job addressing the recommendations outlined in the last review. The review committee recommended that the program be continued. Further recommendations include continuing the United Nations summer program, creating a required introductory-level International Studies course, advocating for adequate support from L&S, and developing a plan to gather data on student time to degree and employment after graduation.

Stuart Moulthrop moved to approve the International Studies report. Laura Stark seconded and the motion carried.

B. Undergraduate Program Review – <u>Journalism, Advertising, and Media Studies</u>
The review committee recommended that the program be continued. Further recommendations include the addition of

more ad/PR electives, additional faculty, especially faculty of color, replacement of outdated hardware, and addressing faculty retention issues by increasing salaries.

The Department requested that the report be rewritten to correct errors and clean-up some language.

Andrew Kincaid moved to table further discussion. Shawn seconded and the motion passed unanimously.

- C. Exceptions to GER Moratorium

There is currently a task force working on reconfiguring/reconceptualizing GER. In the meantime, there is a moratorium on approving new GER.

Julie Ellis moved to approve the exceptions to the GER moratorium. Abera Gelan seconded and the motion carried.

These courses are requesting GER/CD. Kim suggested that we should approve CD courses as exceptions to the moratorium. Mike Darnell pointed out that this is not a grab for more students, but a service to incoming students. The study of languages is inherently cultural. These courses will also serve at-risk students. Kristen Murphy suggested this should go back to the task force. Shawn Cahill noted that CD was discussed by task force, but there wasn't much clarity on how it should be addressed.

Shawn Cahill moved to approve these courses without GER. Stuart Moulthrop seconded and the motion carried.

E. Recommendation to Registrar's Office regarding U/G courses:

APCC recommends that the registrar implement separate sections for all U/G courses starting in a phased approach in fall 2019. Separate sections will better distinguish for instructors those students required to do graduate level work from those required to do undergraduate level work; they will create a permanent record of what level of work the student has completed; and they will facilitate a more efficient and reliable system of double counted credit in accelerated master's degrees.

Kim Pietsch moved to approve the recommendation. Andrew Kincaid seconded and the motion passed unanimously.
