- III. Updates from the Athletic Department:
 - a. Report from Director of Athletics, Amanda Braun
 - i. Commend our student-athletes that continue to have such great success in the classroom.
 - ii. Facility update architect has been selected, kickoff of design phase will occur in the next few months.
 - Baseball May 9th Black and Gold scholarship fund raising event at Milkmen Stadium.
 - iv. Winter sports in the final stretch. Swimming & Diving and Track & Field will have their Horizon League Championships at the end of the month.
 - v. Budget update getting a clearer picture of our challenges for next year. Have let the Student Association know we need their assistance. Next AB meeting will have more of an update.

 - a. 8 days out from starting the season. Practice: fall 3 days a week at Milkmen Field, November come inside, hoping to get out again in March.
 - b. 20-25 minutes in the middle of the day to get the field.
 - c. Milkmen Field The team is super excited. 100% turfed facility. Locker room presence is something they have never had. Dimension: centerfield is 430 feet. We hit a lot of homeruns in the fall, but not to center. We have some speed at centerfield to cover the expanse, the best athlete Scott's had in 25 years.

- d. The field is helping with recruiting, got a recruit this morning that they could not have gotten without the field. Getting more calls back than they have gotten before.
- e. Young team 17/35 that have not played at this level. Super young on the mound. Need to get healthier on the mound, none of the injuries are season ending. Will be learning on the fly with a tough schedule. Open up with Illinois and Wake Forest, Seton Hall, Sacramento State, Oregon. Like to be challenged. Team is academically very good.
- f. Home scheduling- Northwestern and Purdue will be home games, never able to get Big Ten teams to come here in the past. Next year UC-Davis is coming here the week before finals.
 20 home games total this year, 23 next year had 16-17 in past years. Reestablish home advantage in new facility as we were very successful at The Hank.
- g. The Rock hosts the top tournaments in Wisconsin, so now all those kids will see the Home of the Panthers when they compete there.
- h. Finalizing marketing plan for the season. Tickets went on sale last week. Select games will bus students down to the facility.
- i. Horizon League at the top is very good.
- j. Miller Park game is April 17th.
