**A. New/Substantially Revised Courses**

**OCCTHPY 820**

### **1. Architecture, MArch**

The program change request changes to course and capstone requirements.

A motion was made and seconded to table this program change until all courses have been checked by the Registrar's Office to ensure that all courses are graduate courses. Motion passed unanimously.

### **7. Library and Information Science, MLIS / Women's and Gender Studies, MA**

The program change is requesting to clarify requirements regarding electives in Women's and Gender Studies by adding catalog language to be consistent with other graduate programs.

Administrative Note: The admission and additional requirements sections appear as new in the change form because they have been moved from the catalog (CAT) to CIM.

A motion was made and seconded to approve this program change. Motion passed unanimously.

### **8. Library and Information Science, MLIS: Public Library**

The program change is requesting change to number of credits needed. The Public Library Concentration will move to 15 total credits needed. Students required to take

INFOST 736, and either INFOST 861 or INFOST 864, plus an additional 9 credits of Public Library electives to earn the concentration.

A motion was made and seconded to approve this program change. Motion passed unanimously.

**9. Social Work, MSW / Women's and Gender Studies, MA**

The program change is requesting to clarify requirements regarding electives in Women's and Gender Studies by adding catalog language to be consistent with other graduate programs.

A motion was made and seconded to approve this program change. Motion passed unanimously.

**10. Women's and Gender Studies, Graduate Certificate**

The program change is requesting to replace U/G 401 with G only 701 and to change the title of WGS 701.

Administrative Note: Also migrating the admission requirements for this program from the catalog to CIM.

A motion was made and seconded to approve this program change. Motion passed unanimously.

**11. Women's and Gender Studies, MA**

The program change is requesting to replace former U/G course (401) with graduate course (701).

Administrative Note: Also migrating the admission and additional requirement (fka program requirements) requirements for this program from the catalog (CAT) to CIM.

A motion was made and seconded to approve this program change. Motion passed unanimously.

**12. Atmospheric Science, MS**

The program change is requesting to change submission of GRE to "optional". The program is requesting that the change be retroactive to Fall 2020 and to have the change archived for Fall 2020, that the changes complete workflow on October 1<sup>st</sup>.
