1 v)	 a. Covid-19-UWM has a low infection rate and a very good vaccination rate. We will continue to monitor as the semester goes on but things are looking well. b. Students are enjoying being back on campus at near pre-pandemic numbers. This enables them to interact with their peers and campus and engages the campus community. c. Enrollments are better than expected with only a 2.8% lower than expected with only a

2.8% lower than expected rate (Previously a 6.8% drop was expected). A large effort by the campus was made and it worked well to increase student enrollments.

- d. A focus on a more student friendly environment has increased enrollment across the board. Campus will also be looking at in state student recruitment as well as other potential areas for enrollment growth.
- e. Search for UW System President has begun with 2 listening sessions for UWM.
- f. Changes for 2030 continue with a focus on revision to General Education Requirement (GER) courses.
