- III. <u>SPECIAL GUESTS</u>^a Caregiving and COVID Task Force members Lisa Hager, Melinda Brennan, and Elizabeth Liedhegner
 - A. The three guests are the UWM members of the independent UW System Caregiving Task Force. They made a presentation on the work of the task force. Caregiving often is an equity issue, as women tend to share a disproportionate proportion of caregiving in a family. COVID has exacerbated the negative impacts already faced by caregivers.
 - B. The UC was asked to support the efforts of the Task Force to change UWM policies to provide accommodation for caregivers as they pursue their careers. The UC agreed to explore a strategy on how to move this forward.

- A. N. Rothfels met with the Chancellor and discussed COVID planning for next semester, equity issues and enrollment issues with CGS, and the role of the AAFEC in opportunity hires of faculty. The Chancellor indicated that he values the open communication with the UC.
