<u>CALL TO ORDER AND APPROVAL OF AGENDA</u> – The meeting was called to order by N. Rothfels at 1:02 p.m.

II. <u>APPROVAL OF MINUTES</u> – The minutes of the April 5, 2022 meeting were approved.

#### III. SPECIAL GUESTS<sup>a</sup>

Chancellor Mark Mone

- A. The recognition ceremony for virtual commencement graduates this past Sunday was well received by the participants.
- B. 285 people attended the Distinguished Alumni event this past Friday evening. Approximately 30 alumni were recognized.
- C. Work continues on the proposal for reallocation of GPR funds, with ongoing discussions with the System and Regents. The plan for increased scholarship funds would supplement this reallocation, and UWM is targeted to receive a significant fraction of these scholarship funds.
- D. The city will likely designate Building A of the Northwest Quad as a historic building. Building A requires tens of millions of dollars to bring up to code, and more funds would be needed to make the space useful. The state has already designated Building A as a historic structure, but has approved the demolition of the building. There will likely be a legal battle to resolve the dispute.
- E. COVID is being monitored, and there are plans in case changes to the COVID policy are needed.

### Interim Dean Jason Puskar and Professor John Berges

A. There was a discussion that dissertations are required to be submitted to ProQuest prior to graduation. There is an exception for students whose dissertations consist primarily of creative writing. Concerns were expressed that students should not be required to turn over their intellectual work to a for-profit company for distribution, and publishers are increasingly refusing to publish work that is already available through ProQuest. There was an agreement to have the GFC consider the issue and see if policy changes are needed.
