Historically enrollment in INFOST 647 has been high, with the course enrolling 25 students every term, including summers. Our plan is to replace the 3 credit course, INFOST 647, with the 1-credit options: 637, 638, and 639.

It is recommended but not required to give a grading scale. Recommend adding a grading scale. (2) Unclear whether "Advisory Board Social Media Post: Graduate Level Only" is

an assignment appropriate at the graduate level. It looks like a simple announcement. Please indicate why this is assigned only to graduate students.

## MTHSTAT 760

This request for a new course is to meet needs of students in the new MS Data Science program. The program couldn't find this course on campus and would expect potential MSDS students completing the Math/CS emphasis area would be interested in this course.

This culinary medicine course which blends hands-on experiential learning in culinary techniques and cuisines with medical nutrition therapy and nutrition education/communication-related concepts.

This request for a new course is in preparation for the anticipated new MPH track called "Nutrition & Dietetics", several new courses need to be developed for that curriculum. This is the second course in the Medical Nutrition Therapy (MNT) series that students in that track would take.

# **NUTR 796**

This request for a new course is in preparation for the anticipated new MPH track called "Nutrition & Dietetics", several new courses need to be developed for that curriculum. This medical nutrition therapy-focused field experience course incorporates 12-weeks of supervised experiential learning under the supervision of a preceptor(s) in a clinical setting to prepare students for practice in clinical dietetics.

# **NUTR 800**

This request for a new course is in preparation for the anticipate new MPH track called "Nutrition & Dietetics", several new courses need to be developed for that curriculum. This is a course that prepares students make the transition into professional life as well as for the RDN credentialing exam.

# **B.** Program Changes

# 1. Applied Econometrics and Data Analysis, Graduate Certificate

The program change is requesting is to add elective courses. A motion was made and seconded to approve this program change. Motion passed unanimously.

# 2. Cultural Foundations of Community Engagement and Education, MS

The program change is requesting to drop EDPOL 791 as a requirement for the program. ED POL 791 is no longer offered as a regular course because of perennial low enrollment. The requirement that students completing projects take 791 was meant

to support a faculty member to supervise these projects, but since it no longer serves that purpose, and because other capstone options do not require that students take credits, the faculty determined that the requirement was no longer relevant. And changes to the additional requirements text (not actual requirements) to clarify options.

A motion was made and seconded to approve this program change. Motion passed unanimously.

## 3. Educational Psychology, PhD

The program change is requesting to add ED PSY 831as an option for the Psychological Foundations Core requirement. Adding ED PSY 814 as an elective option. The Research Methods Core credits language is changed from 15 credits to "15 credits minimum". The accounts for ED PSY 724, which is 4 credits, while the other RM courses are 3 credits. Level of the research courses (beyond ED PSY 624) is changing to 700+. All specialization in the Educational Psychology PhD will eliminate the GRE as a requirement for admission. GRE scores will be optional, as supplemental material. School Psychology and Counseling Psychology will join Cognitive and Developmental Sciences (CDS) in requiring a sample of academic writing and Educational Statistics and Measurement (ESM) will require a sample of quantitative research/statistical analysis as admission materials. Eliminating the section on students entering the School Psychology without master's section. The course information has been added to the specialization page.

A motion was made and seconded to approve this program change. Motion passed unanimously.

# 4. Educational Psychology, PhD Additional Requirements

The program change is requesting to update the language around advising and the major professor for clarification. The requirement for a publishable paper has not been enforced for years and are requesting to eliminate this requirement. The minor will no longer be required, but optional for all programs.

A motion was made and seconded to approve this program change contingent on revising the language to "in additional to the grad rep, another appropriate person in authority in additional to the advisor who is a separate faculty member". Motion passed unanimously.

## 5. Environmental Health Sciences, PhD

The program change is requesting to move electives to a separate list and revise the text language.

A motion was made and seconded to approve this program change. Motion passed unanimously.

#### 6. Information Science and Technology, MS

The program change request to add text regarding minimum grade requirement for required courses in the program. It was recently noted that this requirement was not present in the catalog. The text mirrors the requirements for the SOIS MLIS program. A motion was made and seconded to approve this program change. Motion passed

A motion was made and seconded to approve this program change. Motion pass unanimously.

#### 7. Information Technology Management, MS

The program change request to add BUS ADM 813 to the electives list.

A motion was made and seconded to approve this program change. Motion passed unanimously.

#### 8. Library and Information Science, MLIS

The program change request to include a statement as part of the minimum grade requirement where: "Materials and assignments used previously may not be reused or resubmitted when retaking a required course unless approved by the instructor.". A motion was made and seconded to approve this program change. Motion passed unanimously.

## 9. Mathematics, PhD

The program change request to clean up course renumbering consequences due the section on Minor for students from other areas was missed before. Requesting to also change the GRE submission requirement in Panthera from "recommended" to "optional".

A motion was made and seconded to approve this program change. Motion passed unanimously.

## 10. Psychology, MS

The program change request to remove the rule that students may not earn more than two degrees from the Department of Psychology at UWM.

A motion was made and seconded to approve this program change. Motion passed unanimously.

# 11. Psychology, PhD
