<u>CALL TO ORDER AND APPROVAL OF AGENDA</u> – The meeting was called to order by M. Schwartz at 1:00 p.m.

II. <u>APPROVAL OF MINUTES</u> – The minutes of the August 30, 2022 meeting were approved.

III. SPECIAL GUEST^a - Interim Provost Scott Gronert

- A. The campus is experiencing a decrease of about 2% in overall enrollment. Undergraduate enrollment is down by about 2.5%, and graduate enrollment is down by about 0.3%. UWM is up about 4% in new undergraduate students, and up about 10% in new graduate students. The freshman-to-sophomore retention rate is down, and efforts are being made to improve the academic performance of this year's freshmen class to keep more students in good standing.
- B. There is some controversy in using volunteers in dining services. The call for volunteers was prompted by the difficulty of finding students for these positions.
- C. The Provost is meeting with Deans tomorrow to discuss rollout of the Teaching Professor title.

IV. CHAIRPERSON'S REPORT & ANNOUNCEMENTS

A. There will be a student survey from UW System about perceptions of free speech rights administered to all campuses later this semester. Geoff Peterson from UW – Eau Claire made a presentation on the survey to UWM governance reps last Thursday. Concerns were raised over the student sampling plan potentially underrepresenting the Madison and Milwaukee campuses. There appears to be competent researchers engaged with the process, and the survey should result in useful data.
