#### Chancellor Mark Mone

- A. The courts have ruled in favor of UWM in terms of demolishing Building A of the Northwest Quadrant. The demolition is ongoing and should soon accelerate.
- B. The UW System Strategic Plan has three primary thrusts: (1) educating the talent pipeline to address the state's needs; (2) addressing the equity gaps; and (3) fostering civic engagement.
- C. The UW System free speech survey will soon be released. Ten thousand students from UWM will be asked to fill out the survey, with a hope of getting a minimum of 500 responses.
- D. The main components of the upcoming budget request are the 4%/4% pay plan increase, a base budget increase of 4%, and the tuition promise program.
- E. Progress continues on the new Chemistry building with a projected opening of January 2024.
