Additional discussions are ongoing on how to potentially deal with deteriorating weather conditions on Thursday and Friday.
- B. The reduction in services by the Testing Center is being revisited by campus administration. The Testing Center was shifted to UITS in an attempt to better coordinate the testing center's work with on-line learning. However, this has led to a lack of services for in-person classes. Concerns were raised about the shift having originally taken place without input from faculty.
- C. An employee has informed the UC that they have completed their required trainings, but the HR system does not recognize this. A question was raised as why to there is no method of employees being able to check the status on which trainings they have completed and which haven't been completed. The Provost will work with the UW System to determine what can be done to make the trainings system more user-friendly.
