UNIVERSITY OF WISCONSIN - MILWAUKEE FACULTY SENATE MEETING MINUTES Thursday, November 16, 2023; 2:30 p.m. Curtin 175 and Microsoft Teams

Chancellor Mone called the Faculty Meeting to order at 2:30 p.m.

I. COMMENTS AND QUESTIONS

1. Chancellor's Report

Chancellor Mone reported on the following topics:

- College of General Studies Transformation Team (CGSTT): Chancellor Mone highlighted the guiding principles for the CGSTT's work, emphasizing a unified approach across UWM, focusing on students, and embracing programming opportunities. Goals for the CGSTT include closing the Washington County facility by June 2024, exploring the future CGS structure, planning future programming, and developing detailed plans for the transformation.
- Pay Plan: Chancellor Mone emphasized the importance of advocacy and negotiations as discussions about the pay plan are ongoing. The Chancellor discussed a recent lawsuit's potential impact on the pay plan and stressed the need for continuous advocacy.
- Deloitte's Involvement: Deloitte, a major accounting firm, has been hired as part of the Universities of Wisconsin's strategic plan to help each campus close its budget deficit. For UWM, the goal is to close the deficit by the end of 2025. Deloitte will conduct financial and strategic assessments, focusing on financial health, strategic decision-making processes, and performance improvement opportunities.
- Enrollments: Chancellor Mone mentioned enrollment trends, noting a small decline but an increase in graduate and international students. He is optimistic about future enrollments trends despite demographic and narrative challenges, citing branding efforts and new leadership.

Senator Anne Widmayer conveyed the sentiments of her colleagues in CGS, emphasizing the desire for more self-definition and autonomy in decision-making, as Washington County has experienced significant challenges and changes over the past decade. Widmayer also inquired about the process or criteria used in selecting CGS representatives to be part of the leadership or decision-making teams.

In his response, the Chancellor explained that the selection of CGS representatives for the transformation process is based on functional alignment. Key considerations include individuals' current job responsibilities, existing faculty leadership roles, and involvement in relevant areas like enrollment management and research. This approach ensures that selected individuals have the expertise and alignment necessary for their new roles. Further details on the selection process are anticipated soon.

Senator Stephane Scholz inquired if there could be consideration for one of the co-chairs of CGSTT to also be a representative from CGS. Chancellor Mone noted that the current two co-chairs handle mostly administrative duties and that decision-making primarily happens at the work team level. Hence, he suggested maintaining the existing two co-chair structure.

MOTION: to extend time by five minutes. The motion was seconded and approved by voice vote.

Associate Professor in the Department of Linguistics Nick Fleisher asked about the recent confirmation of several, but not all, regent appointees by the state Senate. He inquired if this development might indicate anything about the relationship between the legislature and the Universities of Wisconsin.

In response, Chancellor Mone noted that while several of Governor Evers' appointee regents remain unconfirmed, some recent confirmations occurred. He anticipates that more will be confirmed soon. Despite lack of confirmation, these regents continue to have full voting rights and their status has not affected policy decisions; however, a gubernatorial change could have a significant impact.

2. Provost's Report

Provost Andrew Daire hosted a luncheon to celebrate colleagues who were recently tenured, promoted, or received indefinite status. The event facilitated introductions and sharing of research areas among professors.

Following the analysis of five-year enrollment trends showing declines in most undergraduate, masters, and doctoral programs, the Provost requested Deans to review their program arrays. They were asked to identify high-growth potential areas, innovate low-enrollment programs to meet market demand, recommend new programs with growth potential, and consider closing chronically low-enrolled programs. This process may involve reallocating resources to areas with growth potential. Deans are expected to provide preliminary information by February 1st with plans to be finalized by July 1st.

Efforts are ongoing to strengthen partnerships with area technical colleges, including a recent meeting with Waukesha County Technical College (WCTC) to discuss collaboration, transfer pathways, and admission agreements. Plans are in place for a spring meeting with WCTC and a December meeting with Moraine Park Technical College.

The Provost expressed commitment to supporting excellence, innovation, and impact at UWM, highlighting the necessity and potential of transformational change.

- 3. University Committee (UC) Report: Kathleen Dolan, Chair The report is attached.
- 4. Academic Planning and Budget Committee Report: Nicholas Fleisher, Co-Chair APBC has met twice since the last Senate meeting. Its members have been actively involved in unit budget meetings for the next fiscal year. The APBC co-chairs are participating in ongoing discussions with budget leaders on campus and are involved in the Budget Model Review Working Group. The working group's activities will resume in the new year.

The APBC received an update on student retention, focusing on the connection between student support efforts on campus and their impact on retention.

The committee is closely monitoring the situation with CGS, particularly in Washington County, and plans to work with the transformation team, aligning with the APBC's governance role.

Most recently, the APBC reviewed a proposal for a new Master of Science program in Connected Systems and provided feedback on it.

Senator John Boyland asked about assigning a deadline during break to allow students flexibility.

Special Assistant to the Provost Suzanne Boyd confirmed that the proposed policy aims to prevent setting due dates during official university recesses, to ensure students get a break. There was

consideration of the impact on online asynchronous courses and the need to craft the policy language carefully. The policy, which seeks to move from a recommendation to a prohibition of due dates during recesses, is still under refinement and will come to the Faculty Senate for final approval.

V. BUSINESS

 Faculty Document 2784R1: Recommendation of the University Committee to Amend UWM Policies & Procedures Chapter 5.13(1). A senator moved adoption of FD 2784R1. University Committee Chair Kathleen Dolan presented the document.

Senator Kathleen Wheatley raised a question about who decides whether certain years count for faculty members under consideration for tenure or similar positions.

Dolan responded that this decision is typically a conversation between the candidate and the Dean.

Wheatley expressed a preference for giving more decision-making power to the person being hired, rather than having terms imposed on them by others.

Dolan agreed that the UC would likely support giving more say to the individual being hired. She stated that the policy's intent is to allow for flexibility and input from the candidate.

MOTION: To approve FD 2784R1. The motion was seconded and approved with a vote of 34-yes; 1-no; and 0-abstention.

 Faculty Document 3443R1: Request for Authorization to Implement a Bachelor of Arts in General Letters at UWM. A senator moved adoption of FD 3443R1. The motion was seconded. Director of Curriculum & Governance in the College of Letters & Science Kristin Sziarto presented the document.

Senator Kay Wells inquired about whether the self-reflection is replacing the capstone requirement and asked who would evaluate the self-reflection.

Sziarto clarified that L&S no longer has a capstone requirement but instead a research requirement, which is not part of the new self-reflection component due to the majority of research courses requiring a major. To address this, a Canvas site will be set up for students declaring this major, providing them with necessary materials. The students will submit their self-reflections to this site. Initially, the person in the Director of Curriculum & Governance position will evaluate these submissions. However, depending on the number of submissions, the process may be further developed with the involvement of the L&S APCC.

MOTION: To approve FD 3443R1. The motion was seconded and approved with a vote of 34-yes; 1-no; and 0-abstention.

3. Faculty Document 3477: Associate of Arts and Sciences Collaborative Online Program Transition Plan. A senator moved adoption of FD 3477. The motion was seconded. Associate Dean of Academic Affairs in the College of General Studies Greg Ahrenhoerster presented the document.

MOTION: To approve FD 3477. The motion was seconded and approved with a vote of 33-yes; 0-no; and 0-abstention.

4. Report on Diversity, Equity, and Inclusion. Vice Chancellor Chia Vang presented the report. <u>Click here to view the report.</u>

Chancellor Mone highlighted UWM's commitment to fostering cultural and political understanding, especially in response to global conflicts like those in the Middle East. He emphasized the university's role in promoting diverse perspectives and inclusivity, stating that UWM's dedication to diversity is a key factor in attracting students and is a priority across the university's leadership.

VI. UNFINISHED BUSINESS

Chancellor Mone provided an update on the regent appointments made by the state Senate. Regents Adams, Brenkus, Colón, Kreuser, Prince, Staton, and Weatherly received full Senate confirmation on Tuesday.
