a) Discussion on ideas, goals and mission
i. Joshua -Event Idea: "Protect Your Geek" will be a Laser Tag/Paintball event with diverse student Org participation

ii. Benjamin -Cultural Inclusion through Karaoke
iii. Mayya questions the status of the smoking ban on campus. Trevor relays to Mayya that the ban passed and the logistics of how to implement the policies of said band are still in the works.
iv. Trevor states SLIC can also propose statements, letters and legislation; "We can ask, through formal letter" updates on the smoking policy." SLIC can reach out to SHAC to create a better relationship between the two entities. Benjamin states "Maybe SLIC and SHAC can 'swap' members, so each group would know what's going on." Mayya proposes each group could host events in Sandburg (joint events with SHAC)
v. Benjamin suggests SLIC produce public service announcements to general body about SA \& SLIC meetings.
vi. Trevor - "Please use SLIC as a crutch..." Urging members of SLIC to utilize SLIC to help leverage urgency of responses for student affairs is members and other students are not getting answers in a timely or professional manner. Trevor thanks each member (individually) for their input and participation.
vii. Benjamin suggests SLIC take on the role of improving awareness of violence and sexually harassment/rape, as well as, minority rights on campus. Karina has a current sexually harassment/assault case she suggests SLIC can look into.
viii. Mayya would like SLIC to improve Freshman orientation, stating there is too much information thrown at student far too quickly with no follow-up. Joshua suggests hosting "Know Your Rights" sessions through Norris Health. Karina suggests name change of "Know Yourself and Know Your Rights" to promote mental health and well as personal safety.
